The American Medical Association (AMA) reorganized many hernia repair codes for 2023, departing significantly from the prior coding logic. In order to make a clean break with the deleted codes, which do not neatly crosswalk to the new 2023 codes, ParaRev recommends inactivating chargemaster lines associated with the deleted codes and creating new chargemaster line items for the 2023 CPT® codes as described in this paper. See the chart on page 10 for a concise list of the new codes."
